6. The security deposit money exceeding 2% shall be adjustable towards approved bid amount in favour of the successful bidders. The CDR's of the bidders who offer below the reserve bid shall be forfeited.

Bids must be accompanied by CDR/FDR and cost of tender Document as specified in column 4 & 5 of the table payable at Jammu pledged in favour of **Accounts officer, Directorate of Floriculture, Parks & Gardens 24 C/C Gandhi Nagar Jammu.** CDR/FDR shall have to be valid for one year (12 Months).
