Whereas, Sh. Roop Lal was appointed as Class-IV Gardener vide Order No.43-TSM of 1990 dt.16-03-1990 under endorsement No.313-16/JD/GPE dt.19-03-1990 in the Floriculture Department on compassionate grounds;

Whereas, Sh. Roop Lal being a qualified Gardener was promoted as Jr. Head Gardener in the year 2013 by the DPC w.e.f.19-01-2013 vide Order No.389 of 2013 dt.23-02-2013;

Whereas, the official instead of joining as Jr. Head Gardener submitted representation to Administrative Department for considering his case as Head Gardener or Jr. Assistant and the Administrative Department has conveyed to keep the issue in next DPC vide their letter No.Agri/Flori/DPC/2013 dt.13-03-2013;

Whereas, the official was promoted as Jr. Assistant vide this office Order No.153 of 2015-16 dt.11-07-2015 in OPG and the matter regarding confirmation was taken up with the Administrative Department for accord of relaxation of qualification bar. The Administrative Department vide Order No.BPE/Flori/32/2014 dt.24-05-2017 conveyed that any kind of deviation cannot be entertained by the Govt;

Whereas, aggrieved by the non confirmation as Jr. Assistant, the official represented for considering his period w.e.f.19-01-2013 as Jr. Head Gardener and allowing him to join as Jr. Head Gardener as per Order No.389 of 2013 dt.23-02-2013;

Whereas, the official was allowed to join as Jr. Head Gardener in his own pay & Grade vide Order No.214 of 2017 dt.31-10-2017;

Whereas, his case was placed in DPC for settling the issue related to date of confirmation is Jr. Head Gardener;

Whereas, the DPC in its meeting held on 25-08-2018 opined that his promotion case has already been cleared by the DPC in the year 2013 and due to non joining as Jr. Head Gardener, his representation can be dealt administratively to settle the period;

Whereas, vide Order No.270 Estt. of 2018 dt.25-10-2018 under endorsement No.DFJ/Estt./4464-66 dt.25-10-2018, a committee constituted under the chairmanship of Deputy Director (P&S), to settle the period of Sh. Roop Lal w.e.f.19-01-2013 to 31-10-2017;
