5. The intending bidders are advised to go through the details terms & conditions of e-NIT before bidding.

Bids must be accompanied by CDR/FDR and cost of tender Document as specified in column 3 & 4 of the table payable at Jammu pledged in favour of **Accounts officer, Directorate of Floriculture 24 C/C Gandhi Nagar Jammu.** CDR/FDR shall have to be valid for six months or more after last date of receipt of Bid.
