- 7. The approved supplier shall have to supply the material within 30 days from the date of issue of supply order.
- 8. In case the quoted rates of two tenderers are same, the intending officers shall equally distribute the supply order to the two bidders, as approved.
- 9. In case of belated supply, penalty upto 10% of the total cost of that particular supply order shall be imposed upon the approved supplier (s).
- 10. Disputes arising, if any, during or after supply of the material shall be subject to the Hon'ble courts of Jammu only.
