


Sub:-Cancellation of selection of the candidate for the post of "Driver", (Floriculture, Gardens & Parks Department) Divisional Cadre Jammu, under item No. 257 Advertised vide Notice No. 05 of 2015 dt. 01.09.2015.

1. Whereas, the J&K Service Selection Board issued the selection list of the candidates for the post of Driver, (Floriculture, Gardens and Parks Department) Divisional Cadre Jammu vide item No.257(05 of 2015) dated 01-09-2015 and released the recommendations in favour of S. Jasmeet Singh S.No.1/OM and the same was endorsed by the Administrative Department vide letter No.Flori/Refer/134/2015 dt.09-01-2018.
2. Whereas, selection of Sh. Subash Singh figuring at S.No.2/OM was withdrawn/cancelled and the candidate namely S. Harvinder Singh S/o S.
