The appointee shall report to this Directorate within a period of 21 day from the date of issuance of this order. In case of failure of the appointee to join within the stipulated period, his appointment shall be deemed to have been cancelled within any further notice.

The appointee shall be allowed to join only on production of the following certificate (in original);

1. Academic qualification certificate.
2. Matriculation/date of birth certificate.
3. Health Certificate from the concerned Chief Medical Officer of the District.
4. Permanent Resident Certificate issued by the competent authority.
5. Certificate from the District Industries Centre (DIC) and District Employment and Counselling Centre to the effect that no loan under the self-employment scheme has been obtained by the appointee.

The appointment of the candidate shall further be subject to the following conditions:

- I. The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his character and antecedents is received from the Inspector General of Police, (CID), J&K to whom a reference shall be made by the Department of Floriculture, Gardens & Parks, Jammu, he shall have no right or claim to his appointment, as such, shall be deemed to have been cancelled abinitio;
- II. Genuineness of the academic qualification/technical and PRC certificates from the concerned issuing authorities shall be verified.


The salary of the appointee shall be drawn and disbursed to him only after the satisfactory reports in respect of condition (i) and (ii) above are received in his favour.

If, on verification, the certificates produced by the appointee prove to be fake or forged, his appointment shall stand cancelled/abinitio.
